UNITED METHODIST SCHOLARSHIPS ARE AVAILABLE

The deadline to apply is March 24. If you are a United States citizen (which you don't have to be to qualify for one of the General Board of Higher Education and Ministry {GBHEM} scholarships), the applicant must be an active, full member of The United Methodist Church for at least one year, Applicants must be pursuing a degree program at an accredited institution within the United States. High School students may apply if they will be college students in the fall term. Applicants must have a minimum GPA of 2.5 or higher on a 4.0 scale. Applicants are required to be full-time students according to their school's standards for the program for which they are enrolled. A student may receive GBHEM scholarships for up to seven award years maximum. These scholarships are separate from the ones offered by the United Methodist Higher Education Foundation (UMHEF). You can apply to both through each organization.

The funds for GBHEM's loans and scholarships are generated 63 % from endowments, 22% from wills and annuities, 13% from United Methodist Special Sundays, 1% from online gifts, and 1% from fiduciary income. Find out more by visiting www.gbhem.org.

BSA INFORMATION SESSION

On Wednesday, January 26, an information zoom session was held by GNJAC in order to discuss the BSA bankruptcy settlement. According to Bishop Schol, there were more than 300 attendees that participated in this zoom session. Besides Bishop Schol, the session was led by Sang Won Doh, Rob Zuckerman, Vasanth Victor, Kay Dubuisson, Matt Enzler, Eric Drew and Rev. Shelley Smith. According to Victor, all conferences have churches with claims of sexual abuse among sponsored Boy Scout troops. He also claimed that "GNJ is where scouting first took root."

All those on the session were able to participate in a poll in regards to how GNJ will contribute financially to the Survivor Trust Fund of \$910,420. 94% agreed to supporting the fact that the UMC and GNJ will contribute to the Survivor Trust Fund. 88% were in agreement that our congregations should share in the responsibility of this settlement over three years. The exact percentage that churches are to contribute was all over the board, with the majority agreeing with 50%. These and the results to other questions in the poll will assist the team with deciding on legislation for the May 2022 Annual Conference Session.

There is also in play a good faith effort to raise an additional \$100 million, which was stated a few times during the session is not a guarantee! The Boy Scouts of America bankruptcy filing states that there were more than 82,000 claims of sexual abuse that happened since 1940. A report goes on to state that several thousand of these allegations have been committed by United Methodist-chartered Boy Scout troops and Cub packs.Included in the settlement are also other schools, churches, public and private organizations that offered their buildings and property to Boy Scout Troops for their use.

The following terms have been reached so far according to a report put out by Rob Zuckerman, CFO and Treasurer of GNJ:

- 1. Provide an opportunity for survivors to share their experiences and hope for the church.
- 2. Publish a series of articles about the Boy Scout bankruptcy case and the sexual abuse of young people in denominational publications and U.S. annual conference communication resources.
- 3. Review all Safe Sanctuary / Ministry Safe policies and procedures for congregations in the U.S. to ensure they are up to date and are being followed.
- 4. The Methodist Church in aggregate has committed to raise a \$30 million settlement to contribute to the Survivor Trust Fund. This contribution would be 1% of a \$3 billion settlement.
- 5. Ensure that all BSA chartered organizations receive a release for Boy Scout-related claims. While United Methodists have the capacity to organize and have legal representation, most chartering organizations do not. Small community nonprofits, small denominations (including sister denominations of the Pan-Methodist Commission), parent-teacher associations, grange halls and many other chartered organizations were not represented in the mediation process, leaving them vulnerable to future lawsuits. Our United Methodist mediators advocated for their release from BSA claims, not only to assist them but also to help ensure that scouting will be able to continue. (This is why the United Methodists came up with that extra \$100 million dollar goal).
- 6. The United Methodist Church will provide a representative to the survivor working group that will work to make Scouting and youth programs safer for young people.

Many of these claims occurred during the 50s, 60s and 70s. When the question was asked about the possible splitting of the United Methodist Church, it became apparent that there is still plenty of brainstorming that needs to be done with this issue, but Mr. Zuckerman did seem to believe that those churches leaving the fold will still be responsible for their share. As United Methodists, we should feel compelled to assist the victims of this travesty in any way we can. As a person who works with the youth, I believe that they are the future of our church and I cringe every time I hear of these situations. Let's pray for anyone whom has ever been victimized in this way.
